The Honorable Carol Los Mansmann scholarship is awarded annually by the Allegheny County Bar Foundation to one or more women law students attending Duquesne University School of Law who demonstrate a potential for leadership and a commitment to the advancement of women. Applicants must be enrolled in the School of Law and have completed their first year of the day division or second year of the evening or part-time day division. Applicants must be ranked in the top half of the class. The scholarship award(s) will be based on a combination of academic achievement, involvement in extracurricular and other activities, financial need, and an essay. The committee may also base this decision on an interview should the committee deem it necessary. One scholarship in the amount of \$3,000 will be awarded for the 2010-2011 fiscal year.

All applications, including transcripts and proof of class rank (most recent grade reports), should be submitted no later than Thursday, April 15, 2010 to Lorrie K.
