# Public Interest Law Fellowship Program (PILFP) awards stipends to help public service attorneys for the second year

The PILFP Committee recently awarded stipends ranging from \$1,500 to \$3,500 to 25 Public Service Attorneys who have shown exemplary performance and commitment in their fields of law, as well as demonstrated financial need. The PILFP was launched in 2009 through a generous grant from the PA Department of Community & Economic Development in an effort to financially assist committed public service attorneys to enable them to stay in their chosen field of practice. Many of these attorneys are quite passionate about their work and the stipends make it a little easier for them to remain in public service.

### Environmental Law Section establishes Named-Fund for scholarship



The ACBA Environmental Law Section hosted a river cruise fundraiser on June 10, 2010 aboard the River Quest Explorer (the "Green Boat") to raise funds for the newly established ACBF Environmental Law Section Scholarship Fund. This fund will provide annual scholarships to deserving law students at the University of Pittsburgh School of Law and Duquesne University School of Law, who have demonstrated an interest in pursuing a career in environmental law and meet other criteria set forth by the Section. The Section believes the scholarships will play an important role in getting law students involved in environmental law early in their careers and will help maintain interest in the environmental field.

# Public Service Committee provides 1,100 backpacks to local students



The Public Service Committee's Backpack Project recently provided new backpacks filled with school supplies to 1,100 Allegheny County students. The Backpack Project, now in its fourth year of operation, distributed a record number of backpacks, up from 700 last year.
