The grant will partially fund the development, implementation, refinement, and ongoing operations of the program.

If you had an opportunity to talk with any of the nearly 1,000 people who traveled to Pittsburgh to attend the national Equal Justice Conference, you would have heard all the buzz about our great city and the hospitality of the ACBA Host Committee, which was on full display at the welcoming reception at the August Wilson Center. Attendees enjoyed live music from The Blues Devils, line dancing with Roland Ford, a drum circle, and plenty of food and drinks – including pierogies and a Pittsburgh Cookie Table! Supreme Court Justice Debra Todd, PBA President Sara Austin, and ACBA Past-President Melaine Shannon Rothey opened the conference with remarks about access to justice initiatives in Pennsylvania and the important work of the Pro Bono Center.



Pittsburgh Pro Bono Partnership grows with new members and projects

The administrative board of the Pittsburgh Pro Bono Partnership - chaired by Antoinette Oliver of Meyer, Unkovic & Scott – continuously works with legal aid organizations, the courts, and others to identify areas of need for individuals with low incomes facing critical legal issues. The law firm of Blank Rome LLP is the newest member and will partner with member PNC Bank to help clients with the expungement and sealing of criminal records. The new Guardianship Project – led by Pietragallo Bosick & Gordon – will represent families in Orphans' Court to establish guardianships for their loved ones with severe mental or physical disabilities. And the Landlord Tenant Project expanded earlier this year to take on more cases from Neighborhood Legal Services Association. In recognition of the work their attorneys perform through this project, Alcoa, Arconic, and Meyer, Unkovic & Scott will receive an award from the Pro Bono Institute, which will be presented on September 28 in New York City. Congratulations!

Grants help Divorce Law Project serve the most vulnerable

Individuals who wish to take the first step along the road to a new life by ending a marriage can be trapped by the inability to afford legal representation to pursue a divorce. Breaking the legal bond of marriage involves a complicated court process that is difficult for any person to navigate on his or her own. Especially for a physically or emotionally abused person, the interaction with a spouse that may be necessary to pursue a divorce can be intimidating and even dangerous.

Thanks to generous grants from the FISA Foundation and the Pittsburgh Foundation, over the past year the Divorce Law Project was able to increase outreach and substantially increased the numbers of domestic violence victims served by our staff and volunteer attorneys – from 43 in FY 2015-2016 to 71 in FY 2016-2017, in addition to hundreds of other clients. The FISA grant also helped the project expand into Beaver and Butler counties, where previously no such help was available. The foundation will seek a renewal of this funding so that we can continue to provide this critical service.
