### **CLE Credit for Pro Bono**

The Pro Bono Center has been approved as an Accredited Provider of Pro Bono CLE by the Pennsylvania CLE Board. Under the new pilot program approved by the Supreme Court last year, attorneys may earn up to three CLE credits annually at the rate of one credit hour for every five hours of pro bono service reported by an approved pro bono CLE provider. The Center is in the process of developing forms and procedures for making referrals to volunteers and reporting credits under this program. Stay tuned!

#### Numbers at a Glance 2018

In addition to referring cases to volunteer attorneys, Pro Bono Center staff attorneys – with the assistance of a part-time law student – provide direct legal services to hundreds of people every year through our Divorce Law Project and other programs. Here's who our staff served in 2018:

- 576 individuals provided with advice, brief services, or full representation
- 637 people connected with other legal aid providers
  - 96 final divorce decrees entered by the Divorce Law Project
  - 21 domestic violence victims represented at final Protection from Abuse hearings
