Fellows Legal Aid Grant Recipients



The ACBF distributed *\$65,000* in

funds generated through the Fellows program in early 2022. After a competitive selection process, the following legal aid organizations and projects were awarded grants: 1Hood Media, Christian Immigration Advocacy Center, Christian Legal Aid, Education Law Center, Focus on Renewal, Jewish Family & Community Services, KidsVoice, Neighborhood Legal Services, North Hills Community Outreach, Pennsylvania Immigration Resource Center, Pennsylvania Women Work, Pittsburgh Mercy's Operation Safety Net, and Women's Center & Shelter.

Military Veterans & Elderly Fund Grants

The ACBF Grants Committee awarded *\$3,427.97* to Neighborhood Legal Services to provide legal assistance to military veterans and older adults.

Derrick Bell Clinic



The Pro Bono Center collaborated with the ACBA Homer S. Brown Division and the University of Pittsburgh's Black Law Student Association to hold a community legal clinic in November 2021. Ten volunteer attorneys assisted 26 clients with a variety of legal issues, including wills and estates, criminal records clearing, and family law, among others. This annual clinic is held in memory of civil rights attorney and Pitt professor Derrick A. Bell. Pitt's Hill District Community Engagement Center served as the host location.

Pro Bono Center Wins Grants to Help Clients

Facing a decrease in funding at a time when clients are still struggling with the economic impacts of COVID-19, the Pro Bono Center secured grants from The Pittsburgh Foundation and PNC Charitable Trusts to continue its work. We engaged a non-profit translation service to translate the Divorce Law Project application into Spanish, allowing us to better serve clients referred to us from places like the Latino Community Center. Early this year, we were able to provide an attorney to a woman who had experienced physical abuse and threats of gun violence, and she obtained a final protection from abuse order. Our funders' support helped make this possible.
