## 2016-17 Fellows Grant Recipients

Generous donations from Fellows will allow the ACBF to distribute \$35,500 in grants to the following legal service agencies in January 2017:

### Christian Legal Aid

To continue to expand the legal aid provided to members of the community up to 250% of the Federal Poverty Guideline to meet the ever-growing need in Allegheny County.

#### Focus on Renewal

To continue to provide low-income individuals and families with legal assistance for non-criminal matters and with legal documents, such as wills, power of attorney, and health care directives.

### Jewish Family & Children's Service of Pittsburgh

To train 15-20 pro bono attorneys to assist clients with citizenship and naturalization applications in community workshops, thereby increasing capacity to assist 30-40 additional clients with applications for citizenship.

### Neighborhood Legal Services Association

To educate and assist low-income individuals who are experiencing financial difficulties and facing bankruptcy about income contingent student loan repayment plans and to educate low-income students and their parents about the debt weight of student loans.

### North Hills Community Outreach

To help low-income and elderly individuals access the legal resources they need, including arranging one-on-one legal consultations with attorneys through the Ask the Attorney Program.

### Women's Center & Shelter of Greater Pittsburgh

To support the Civil Legal Project which provides representation and advice on civil legal matters in divorce cases involving intimate partner violence.

# ACBF provides grants to benefit the elderly

In January 2017, the ACBF will award \$7,500 in grants from the Military Veterans & Elderly Fund to assist the following organizations in their efforts to provide legal services to the elderly in our community:

### Achieva

To provide outreach, education, and guidance regarding assets, wills, trusts, and powers of attorney so that elderly caregivers can make a plan, and to engage and educate local attorneys on proper planning for families of individuals with disabilities so that these caregivers have access to competent and affordable legal assistance.

### North Hills Community Outreach

To help low-income and elderly individuals access the legal resources they need, including arranging one-on-one legal consultations with attorneys through the Ask the Attorney Program.

### Pro Bono Week Celebrations

A whirlwind week of activities celebrated the lifechanging work that volunteers perform on behalf of individuals and families with low incomes in Allegheny County. The Public Service Committee kicked off the week by hosting volunteers, legal aid attorneys, and members of the judiciary for a festive lunch at the Rivers Club, complete with door prizes. The Pittsburgh Pro Bono Partnership held its annual meeting at which Dr. Jim Withers – one of the 2016 CNN Heroes top 10 – spoke about how professionals intersect with the lives of homeless persons. Finally, the Pro Bono Center hosted a CLE program at which dozens of attorneys were trained to prepare petitions for criminal records expungements. A city-wide expungement clinic will be held in November to match these new volunteers with people in need.
