During 2012, the Foundation continued to grow and explore new ways to meet the demands of providing pro bono services to low income individuals, children, and families in Allegheny County facing critical legal challenges. Through the efforts of volunteer attorneys, and under the direction of Pro Bono Coordinators Barbara Griffin and Elizabeth Parker Gaetani, Pro Bono Center member programs and organizations served approximately 6,583 individuals. Two new pro bono projects were created and existing projects were expanded, and 413 volunteers were trained. The Pittsburgh Pro Bono Partnership received a 2012 Super Lawyers Pro Bono Award.

Through your generosity, Attorneys Against Hunger raised \$109,000. Your public service provided over 1,000 backpacks for children who otherwise would not have the necessary supplies to start their school year.

Twenty-six Fellows and five Young Lawyer Fellows were inducted to the Fellows Class of 2012. Your pledges to the Fellows Program provided over \$30,000 in grants to public service organizations for their initiatives.

The ACBA Board of Governors approved a Young Lawyers seat on the Foundation Board. Our first Board member, Jill Beck, was elected and assumed her

seat in November 2012. The support and participation of young lawyers in our program and projects is essential to the future of the Foundation.

The Foundation held its third Zittrain Forum on Law and Public Policy, and had record attendance at a CLE featuring John Dean and a discussion of Watergate. The Forum is supported by the generosity of the Zittrain Family.

We received continued financial assistance from the Association through the Board of Governors, and appreciate their support of the vital work we are doing.

The future is exciting for the Foundation. We are grateful for the generous financial commitment of member firms of our Leadership Circle, and hope to include additional members. The newly developed Planned Giving Program will provide a sustainable path for the future.

The Allegheny County Bar Foundation raised over \$327,000 through the support of dedicated law firms that have taken the lead by joining the **ACBF Law Firm Leadership Circle** in order to help the foundation continue to provide much needed pro bono legal services and public interest work in the community.

The **Leadership Circle** consists of law firms that have made a financial commitment to the foundation by pledging to donate on a sustaining basis over the next three years to secure the administration of Foundation programs well into the future.

In just the first year, the Leadership Circle firms' financial support has enabled us to respond to the significant cuts to programs which provide legal services to those that cannot afford legal representation in our community. We have also been able to concentrate on developing a strong gift giving plan to secure the continuation of our plans in the future. Here are just two significant ways your funds have helped:

Meeting the Present Need - Expanding our Pro Bono Program: There have been significant cuts to legal programs which provide legal services to those that cannot afford legal representation in our community. When the community cannot find the services anywhere else, they turn to the foundation's Pro Bono Center. This funding has enabled us to hire Elizabeth Parker Gaetani, our new full-time

Assistant Pro Bono Coordinator, and to develop and expand pro bono programs to fill these gaps. We now have the resources to enlarge our volunteer pool by educating more attorneys on ways to participate in a meaningful way that can fit into their already busy schedules.

Securing the Future - Developing our Gift Planning Program: We were also able to hire a consultant to assist us with developing our gift planning program which will help with long-term financial planning and help sustain the foundation well into the future. This also will enable us to grow our Endowment which will have a direct impact on securing our future programs. We will begin to start implementing the gift planning program in the next few months.

The Leadership Circle Law firms have become an integral part of our ability to increase our vital pro bono, educational and philanthropic programs. We hope this leadership support sends a strong message to our attorneys that this work is important and we need your continued support both financially and by volunteering!

On behalf of our Board of Trustees and our volunteers, we give our heartfelt thanks to the law firms for sharing in our efforts to make a positive impact on both the bar and the community.



The Pro Bono Center's programs and member organizations assist thousands of low-income individuals seeking help for legal issues that affect basic human needs as housing, protection from domestic violence, child custody, and income maintenance. At the same time, the Center helps attorneys in Allegheny County fulfill their ethical responsibility to provide public interest legal services. The Center's unique ability to leverage the over 6,400 members of the Allegheny County Bar Association to develop and support pro bono programs makes it a vital resource for the public, the courts, and the community of legal professionals. Thanks in large part to the law firms that joined the foundation's Leadership Circle, the Center increased its capacity to provide services by hiring Elizabeth Parker Gaetani, Esq., as Assistant Pro Bono Coordinator in January 2013.

Volunteer attorneys change the lives of thousands of low-income individuals each year through legal representation and advice. These attorneys, along with judges, paralegals, law students, administrative professionals, and others also promote access to justice by helping to create new pro bono programs and by serving as CLE faculty, project managers, intake coordinators, and much more.

Taking a Stand for Justice

In June 2013, ACBA Board of Governors passed a resolution—proposed by the Public Service Committee—to advance equal access to justice in Pennsylvania.

“NOW, THEREFORE, be it RESOLVED that the Public Service Committee of the Allegheny County Bar Association urges the Commonwealth of Pennsylvania to establish a right to legal counsel for low-income persons in civil legal proceedings where basic human needs are at stake, such as those involving shelter, sustenance, safety, health, or child custody.”



A MESSAGE FROM THE JUVENILE COURT PROJECT DIRECTOR

“The Juvenile Court Project (“JCP”) provides free legal representation for indigent parents in dependency and termination of parental rights cases.”

In fiscal year 2012-2013 the JCP represented over 1,200 clients concerning nearly 2,000 children in over 8,500 hearings. Dependency cases are heard every three months.

The JCP also engages in out of court advocacy by participating in two statewide roundtable workgroups: One tasked with addressing legal representation standards for attorneys representing parents and children in Juvenile Court and one tasked with addressing visitation practices for parents and their children who are placed in out of home foster care placements. Locally, JCP staff participates in several Allegheny County roundtable workgroups addressing a number of dependency issues such as father engagement and educational outcomes of dependent children.

In 2012, the JCP also joined an amicus brief supporting the right of parents to challenge final custody orders entered for dependency cases closing with a goal of permanent legal custodianship. This effort was successful as the Pennsylvania Superior Court upheld the right of parents to challenge the same and the Pennsylvania Supreme Court denied allocatur in the case.





The Pittsburgh Pro Bono Partnership is a collaboration of legal departments, law firms, the Allegheny County Bar Foundation, and Neighborhood Legal Services Association. The Partnership encourages new and more creative efforts to provide legal services to persons of limited means and to those organizations, including charities, which work on their behalf.

The Pittsburgh Pro Bono Partnership continues to expand. In 2012, the Partnership welcomed new members BNY Mellon, Metz Lewis Brodman Must O'Keefe LLC, and Meyer, Unkovic & Scott LLP. New Signature Projects include the Criminal Records Expungement Project, the Family Law Appellate Pro Bono Project, and the addition of two new Wills Project locations in Crafton and the North Side.

The Pittsburgh Pro Bono Partnership was one of seven winners of the 2012 Super Lawyers Pro Bono Award. This national award honors legal professionals and organizations that exemplify excellence in the practice of law through offering volunteer legal services to the poor and disadvantaged.

The Annual Breakfast Meeting, featuring a roundtable discussion highlighting the challenges and rewards of pro bono work, was held on October 25, 2012, hosted by K&L Gates.

Community Grants

The bar foundation is pleased to provide grants to community organizations that make an impact in the lives of disadvantaged and vulnerable residents in Allegheny County. The ACBF Grant Making Committee meets annually to select organizations that meet the bar foundation's funding requirements and serve the community through legal service, education, and/or philanthropy.

Legal-Aid Grants

Donations made to the Fellows Program and the Endowment Fund allow us to continue to award grants to organizations that provide direct pro bono legal services to low-income clients.

In January 2013, we awarded \$30,600 in grants to:

Education Law Center

To train, support, and work collaboratively with volunteer pro bono attorneys assisting parents on matters of public education, including issues related to special education, school discipline and access and education in charter schools.

Jewish Family & Children's Service of Pittsburgh

To provide training, professional supervision, oversight, and mentorship to pro bono attorneys assisting indigent youth who apply for Deferred Action to remain legally in the United States.

Neighborhood Legal Services Association

To support the Unemployed PFA Victims Assistance Project to respond to the needs of PFA victims and increase the resources available to them so they do not reengage in abusive relationships.

Pittsburgh Mercy Health System/ Operation Safety Net Project HELP (Homeless Experience Legal Protection)

To help homeless individuals regain proof of identity, such as birth certificates, social security numbers and drivers' licenses, and to help them secure social benefits such as food stamps, social security benefits, child care, utility assistance, veterans benefits and other social services.

Women's Center & Shelter of Greater Pittsburgh

To provide representation and advice on civil legal matters in divorce cases involving intimate partner violence.

Military Veterans & Elderly Fund Grants

We awarded \$8,000

from the Military Veterans & Elderly Fund to the following programs:







“How Watergate Revolutionized Legal Ethics” April 19, 2013 – Omni William Penn Hotel





Total Revenue \$2,240,343




Total Expenses \$1,838,922




Allegheny County Bar Foundation FY 2013 * Unrestricted - Operating
