Overview & Key Activities

It has been a very busy year here at the Allegheny County Bar Foundation and we are so grateful to all our volunteers and donors! Here are just some of the highlights:

In response to current impending legal needs in the community, our **Pro Bono Center** has helped create the **ACBA Immigration Lawyers Committee Pro Bono Asylum Law Project** and collaborated with Jewish Family & Community Services to train attorneys to represent immigrant children. With the addition of the **Christian Immigration Advocacy Center**, the Center now has **42** member projects and organizations which served over **6,000** individuals in 2018 in a wide variety of areas. Of those, the Pro Bono Center directly assisted, represented, or referred **1,213** individuals in need of legal help. We continue to remain a regional leader in providing and supporting free legal services to the those in need.

The Foundation's **Fellows' Grants Program** and the **Military Veterans and Elderly Fund** awarded **\$52,000** to **12** organizations to assist with furthering their pro bono and legal-related public services efforts.

The **Gismondi Fund** and the **Lawyers' Fund** awarded stipends to a combined **15** certified second-year law students through their **Summer Law Student Fellowship Programs**. These students had an opportunity to work for 10 weeks at organizations providing direct legal services to the poor. The fellowships provided much-needed assistance to the organizations and gave the students opportunities to gain real client experience inside and outside of the courtroom.

Our **Loans & Scholarships Programs** awarded **\$39,000** to **16** law students to assist with the ever-increasing law school debt.

We held **8** fundraising activities, including, **Attorneys Against Hunger, Fellows Program, Golf & Bocce Tournament, Annual Campaign, Jeans for Justice** and **Cocktails for a Cause!**

We celebrated and honored **34** new Fellows, **6** outstanding pro bono volunteers and **2** long-standing Lawyers' Fund Committee volunteers at the Foundation's Fall Reception in September 2018.

We are grateful for all of our Grantors and Donors, including **IOLTA, BNY Mellon, and Association**

of Corporate Council, and the **35** law firms who have joined together to be a part of our Leadership Circle! We would also like to give a big **Thank You** to our pro bono volunteers, Trustees and hard-working committee members. You helped to make all of these programs possible!

Pro Bono Center

The Center is grounded in a network of projects and organizations that work collaboratively to address the legal needs of individuals in Allegheny County with very low incomes. We work with our partners in the courts, social services agencies, legal aid organizations, and many others to identify areas in which individuals are in dire need of legal services and take steps to try to meet those needs.

Starting Life Anew

Assistance from the Pro Bono Center often means a chance for a new start in life for people who cannot possibly afford an attorney for the serious legal problems they are facing. Over the past year, the Divorce Law Project helped **98** people move on from their marriages. Through a grant from the John A. Meehan Citizenship Institute, a refugee from Burma was able to become a naturalized American. The Pro Bono Center also worked with other legal aid organizations to recruit and train volunteer attorneys to handle criminal records expungements, lowering barriers to employment and housing for hundreds of Allegheny County residents. ***This work changes lives.***

Supporting Our Profession...and Our Communities

The Pro Bono Center also helped several attorneys receive emeritus status under a 2018 Supreme Court rule that permits retired Pennsylvania attorneys to be licensed to practice solely for the purpose of providing free legal services.

We continue to provide CLE training, malpractice coverage, free online legal research through a grant from LexisNexis, and many other types of support with the goal of helping attorneys fulfill their professional responsibility to give back and to enhance equal access to justice for all.

Held at the Pittsburgh Field Club on October 8, 2018, over \$30,000 was raised to benefit both Neighborhood Legal Services and the ACBF. It was originally scheduled for July 23rd but was rescheduled due to weather.

Fellows Legal-Aid Grants Program

The ACBF awarded \$40,000 in grants this past year to support local organizations with their efforts to expand pro bono services to clients with low incomes.



Achieva was able to educate both attorneys and families on the concept of special needs planning which helped an elderly couple develop an estate and secure the future of their adult daughter who has been diagnosed with a mental illness.



A **Neighborhood Legal Services** team (lawyer, law student and social worker) helped an 85-year-old woman find safe, affordable housing after her existing landlord refused to make repairs to a very dilapidated home and threatened eviction.

Military Veterans and Elderly Fund Grants

This fund awarded \$12,000 to help veterans and the elderly with pending legal issues.



Neighborhood Legal Services hired a dedicated attorney trained to handle Veterans' claims which has solidified Neighborhood Legal Services' presence in the community to address housing and income maintenance issues related to veterans' benefits, social security and unemployment.

Summer Law Student Fellowship Programs

The Gismondi Fund sponsored 4 Fellowship positions to students who completed their second year of law school at the University of Pittsburgh School of Law and became certified to represent clients in accordance with the court rules of Allegheny County. The Lawyers' Fund sponsored an additional 11 Pitt and Duquesne law students. The student Fellows had the opportunity to earn real-world experience handling legal matters – including client contact – at public service organizations.

Attorneys Against Hunger



Thanks to the generosity of the Pittsburgh legal community, the 2018-2019 Attorneys Against Hunger campaign raised over \$116,000. Since its inception in 1993, AAH has raised over \$1,922,000 – every dollar going directly to help those of our community facing hunger and food insecurity.

In addition to the fundraising side of the campaign, AAH also hosts four outreach events during the campaign. These outreaches allow our volunteers to help our community meet its challenges in a hands-on way. We have helped to prepare and serve lunches to those in need, to pick up food donations from local businesses and deliver them to food pantries, and to sort and pack goods for pantry distribution days.

By partnering with 17 local hunger-relief organizations, Attorneys Against Hunger is able to make a significant positive impact for some of the most vulnerable members of our society.

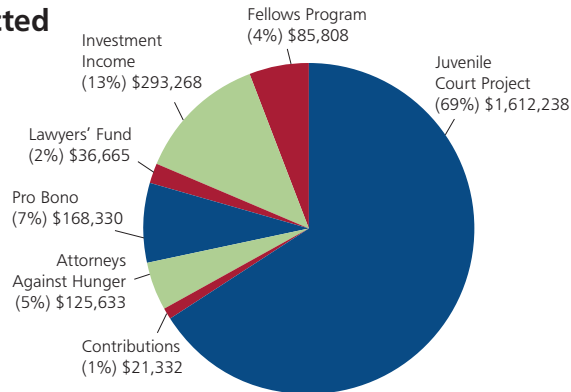

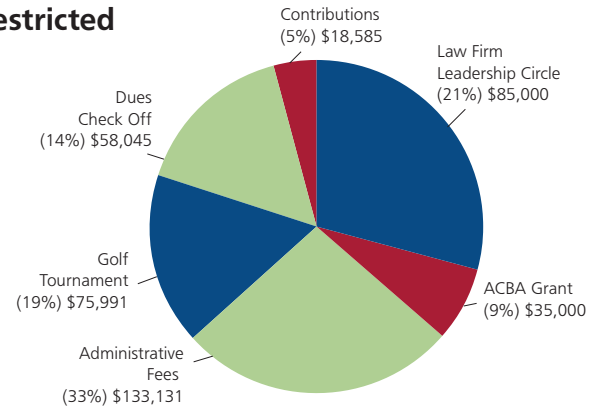

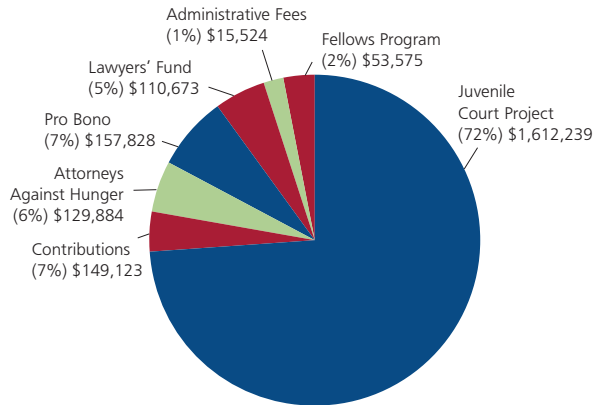


Total Revenue \$2,343,264

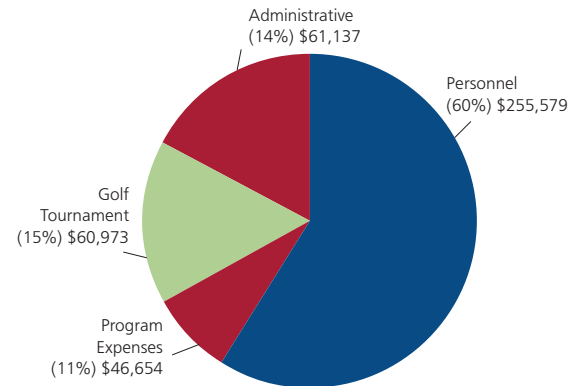
Unrestricted
