




2020-2021 Gratitude Report

### Because... justice matters.

The Pro Bono Center is the nexus between the members of the bar association and its more than 40 projects and member organizations

that provide direct legal services to individuals with low incomes. Volunteer attorneys have access to the support they need, including free or reduced fee CLE training, free online research, mentoring, and malpractice insurance, as well as volunteer opportunities through the Center's projects, organizations, and new initiatives.

### **Celebrating Pro Bono!**

The Pro Bono Center and Public Service Committee celebrated National Pro Bono Week – Oct. 25-31, 2020 – and the life-changing work that volunteers perform on behalf of clients with low incomes.

An Ethics CLE was held Oct. 28 to empower pro bono volunteers to better serve their clients. Participants used "Broke—the Game," a learning tool created by Dana Gold, to simulate the stress of living in poverty and how limited options and systemic obstacles can lead to a downward spiral.

A virtual celebration of volunteers was held on Oct. 29. Attendees heard from ACBA and ACBF leadership, Neighborhood Legal Services, and the Pennsylvania Bar Association. Attendees received a pro bono mask and answered trivia questions for which other prizes were given. And in a special cameo appearance, Roberto Clemente, Jr. shared words of thanks and inspiration for volunteers!

### Juvenile Court Project

Throughout the entire 2020-2021 fiscal year, the Juvenile Court Project (JCP) staff worked remotely and conducted hearings via Microsoft Teams.

In November 2020, the Allegheny County Department of Human Services (DHS) approved funding for the JCP's proposal to pilot an interdisciplinary model of legal representation which began in June 2021. This program has enabled the JCP to expand its staff by 7 new staff members and assist clients with a variety of issues including housing, community resources, public benefits, and insurance issues. They help clients enroll in many additional services to pursue their education goals and assist with their children's medical appointments, including understanding Children Health Evaluation and Coordination Services (CHECS) Nurse Reports, Individual Education Programs (IEPs), and completing documents necessary for school enrollment. In March, they also began offering assistance to sign up for free Chromebooks and hotspots through a program run by Allegheny County DHS.

# Retirement is a new way to give back

#### Emeritus attorneys continue to help clients

A Pro Bono Center initiative was the impetus for a statewide rule adopted by the Pennsylvania Supreme Court in 2018, which allows retired attorneys to be licensed solely for the purpose of providing free legal services through organized legal aid and pro bono programs. To increase

the rolls of emeritus attorneys, the Pro Bono Center partnered with the ACBA Senior Lawyers and Public Service Committees to hold a CLE program in October 2020 on the rule and share volunteer opportunities. Then in June 2021, the ACBA Board of Governors approved a change to the ACBA By-Laws to create a new membership category for emeritus attorneys, with a reduced annual fee and 8 free hours of CLE programs through the bar. The Pro Bono Center is here to assist attorneys who keep giving back, even after retirement.

### Lowering Barriers to Employment & Housing The Pardons Project

Individuals who faced barriers to employment, housing, and education because of old criminal records suffered an even greater degree because of the massive downturn in the economy and record unemployment during the COVID-19 crisis. In the Fall of 2020, the Pro Bono Center partnered with Neighborhood Legal Services to create a project to clear criminal records through the pardons process. The project was made possible by a grant from the Pennsylvania Legal Aid Network. Volunteer and staff attorneys helped 21 individuals start on the path to new opportunities.






# Meeting needs in innovative ways

### Law students assisted with domestic violence cases

COVID-19 created a myriad of challenges not only for clients, but for everyone who is part of the legal system. The Pro Bono Center partnered with Neighborhood Legal Services to train law students – many who lost their summer internship opportunities because of COVID – to prepare attorneys for final protection from abuse hearings. The students researched publicly available court documents to help the attorneys understand the positions of the parties in the cases. The students honed their research and analysis skills, and the attorneys received useful help.



# Because... community matters.

### **Attorneys Against Hunger**

Just when the community needed us the most during the pandemic, we raised **over \$146,000** this year! Even though we were not able to have outreach events, our donors stepped up to the plate. Many hunger organizations did not have the volunteers this year and had to rely on their small staff to meet the increasing need.

Rainbow Kitchen's staff of five have been doing their work and the work of 200 volunteers for the past year. Since March 2020, they have not engaged with any volunteers to assist with their operations.

EECM staff hard at work

East End Cooperative Ministry (EECM)'s food pantry program provides families with healthy groceries each month. They have gone from serving 30 individuals a day (*each representing a family unit*) before COVID-19 to serving 100-140 individuals a day since COVID-19. The food pantry had 21,433 visits in 2020 compared to 7,515 in 2019.



### **Fellows Grants**

Fellows Grants are awarded to help fund programs that directly provide pro bono counsel to low-income residents in Allegheny County and/or promote the public understanding, interest, and support of legal-related issues. In 2020, the following organizations received a total of \$50,000 in assistance.

Christian Immigration Advocacy Center Christian Legal Aid Education Law Center Focus on Renewal Jewish Family & Community Services KidsVoice Neighborhood Legal Services North Hills Community Outreach Women's Center & Shelter



### Jewish Family & Community Services

JFCS was able to help youth like Karamia, who came to the U.S. as a Bhutanese refugee from Nepal, to complete their N-600 application for Certification of Citizenship so that they can pursue higher education and employment goals.

### Neighborhood Legal Services

NLS was able to continue its efforts at the Medical Legal Collaboration at Children's Hospital Primary Care Clinic in Oakland to train hospital staff to recognize the legal issues which affect their patients and how such issues impact their medical efforts on behalf of the children.

Nevaeh, a child suffering from a serious learning disability, mild intellectual deficits, and asthma, needed a more restrictive individualized Educational Plan to function and SSI benefits to address her problems. NLS, working with her pediatrician through the Clinic and teachers, was able to help Nevaeh get SSI benefits and a more restrictive Individualized Education Plan.

The Honorable Carol Los Mansmann Scholarship was established to honor her memory. Each year, the fund awards a scholarship to a female law student attending Duquesne University School of Law who demonstrates a potential for leadership and a commitment to the advancement of women.

It made me believe in myself even more that I will be able to make a difference in the lives of the women and children I advocate for. ### F.C. Grote Fund Scholarship Winners

The F.C. Grote Fund is part of the Lawyers' Fund of the bar foundation, which was established to give scholarships, fellowships, and grants-in-aid for research, writing, and other study of law and of the administration of justice. The Fund awarded \$35,000 to seven students who attend University of Pittsburgh School of Law and University of Pennsylvania Carey Law School.





Total Revenue \$4,091,229






