Helping in the fight for food security

Imagine being homeless in Pittsburgh, living somewhere in the city that meets the minimum standards of living: the clothes on your back, shelter from the weather (usually under a bridge or overpass), and food wherever you can find it. That's where Attorneys Against Hunger (AAH) makes a real difference. AAH raises funds to support 17 local organizations fighting to end hunger in Allegheny County. As a part of our program, AAH supports the Downtown Ministerium Walk-In Ministry, a collection of 5 churches that take turns all week feeding those in need. The lines are long, but the resources are good. Your AAH donations continue to help to increase these churches' ability to provide much-needed food to members in our community who may not find it any other way.



AAH's grant is the largest single source of income for Trinity Episcopal Cathedral's food pantry and program. The Ministry serves 3-to-5 days of food to between 40 and 110 households that represent upwards of 175 individuals.



The Red Door Program provides bagged lunches which typically consist of at least 2 sandwiches, soup or salad, fresh fruit, juice box, water and pastries and are distributed Monday through Saturday to more than 100 persons each day.

PRO BONO CENTER

Allegheny County Bar Foundation

A national study by the Legal Services Corporation in 2017 found that 71% of households with very low incomes experienced a legal problem in the previous year, but only a small fraction of them got legal help for those problems. The Pro Bono Center's mission is to help bridge that gap and one way we do this is by connecting attorneys with communities in need. Community legal clinics and informational sessions bring volunteer attorneys into neighborhoods and are a vital piece of the fabric of free legal services in Allegheny County.

In the past year, volunteers helped prepare wills and other advanced planning documents at the Grayson Center in the Hill District and at Operation Better Block in Homewood. They staffed legal resources tables at events serving the elderly and at the Urban League of Pittsburgh's annual Thanksgiving food distribution. These events were in addition to the ongoing community legal clinics managed by volunteer attorneys and Pittsburgh Pro Bono Partnership firms and corporations that serve residents of McKees Rocks, Millvale, Uptown, and others.



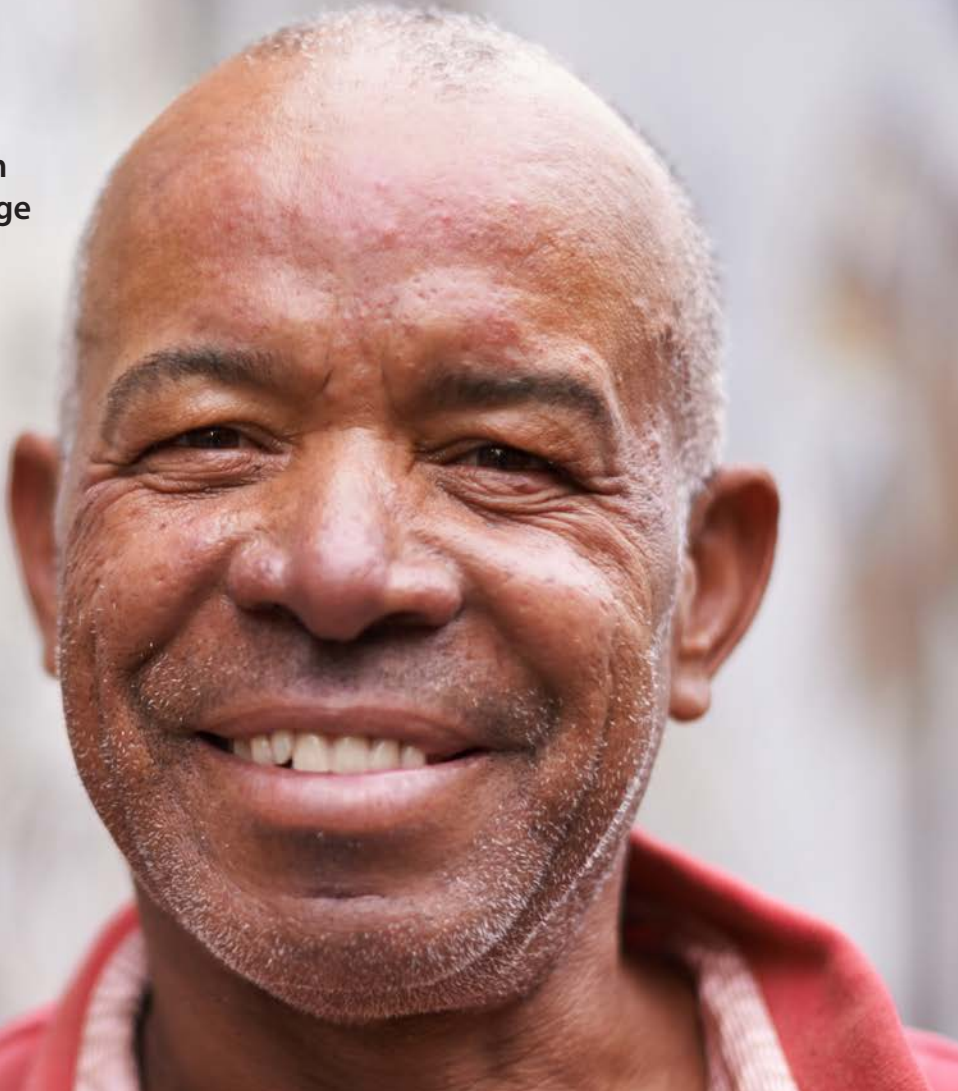
Changing Lives

With over **40** member programs and organizations, the Pro Bono Center remains a critical nexus between the legal community and individuals in desperate need of free legal services. In 2017, volunteer attorneys provided services to nearly **7,000** individuals in Allegheny County in a wide variety of areas. Of those, **844** were helped directly by Pro Bono Center staff attorneys, law student interns, and volunteers. We continue to offer training, support, malpractice coverage, and free on-line legal research with the goal of helping attorneys to fulfill their professional responsibility to give back and to enhance equal access to justice for all.





New Emeritus Rule Allows Retired Attorneys to Keep Giving

In May 2018, the Pennsylvania Supreme Court approved a new rule that permits an attorney admitted in Pennsylvania who is registered as retired to transfer to emeritus status and be authorized to provide pro bono legal services under the auspices of an eligible legal aid organization. This rule is the culmination of an effort that began in 2012 when the Pro Bono Center worked with the ACBA Senior Lawyers Committee to convene a statewide working group to research similar laws in other states and prepare a proposed rule for Pennsylvania. With the support of the Public Service Committee and the leadership of the Allegheny, Philadelphia, and Pennsylvania bar associations, the proposal was adopted by the Supreme Court in substantial part, creating a new way for retired attorneys to continue to use their experience and skills to benefit Pennsylvanians with low incomes.

Volunteer attorneys are a part of helping the Pro Bono Center to advance initiatives that make an impact on expanding the availability of free legal services to those in need.

ACBF Lawyers' Fund Law Student Summer Fellowship Program

This past summer, I worked with the immigrant community in Pittsburgh. In my placement at Jewish Family and Community Service's Immigration Legal Services, I helped countless clients from all over the world get green cards or citizenship, including families from Aleppo, Syria, and Bhutan. As the only low or no cost legal immigration service in this half of Pennsylvania, all of West Virginia, and parts of Ohio, our case load was staggering.

This past summer immigration law was tumultuous. As the only state besides Texas with a Family Detention Center, Pennsylvania is at the heart of the child immigration crisis. The recent mass confusion and separation at the border reverberated here in Pittsburgh with our clients and the community. Jewish Family and Community Service assists unaccompanied immigrant children in Family Court to receive Special Immigrant Juvenile Status ("SIJ") and in Immigration Court.

Ultimately, this experience made me consider what it means to be an American and appreciate the rights and privileges that we have as United States citizens. Without the Allegheny County Bar Foundation's Summer Fellow Program, I would never have been able to explore this area of law or aid the many refugees and immigrants in the Pittsburgh area.

Held at the Club at Nevillewood on July 17, 2017, over \$30,000 was raised to benefit both Neighborhood Legal Services Association and the ACBF.



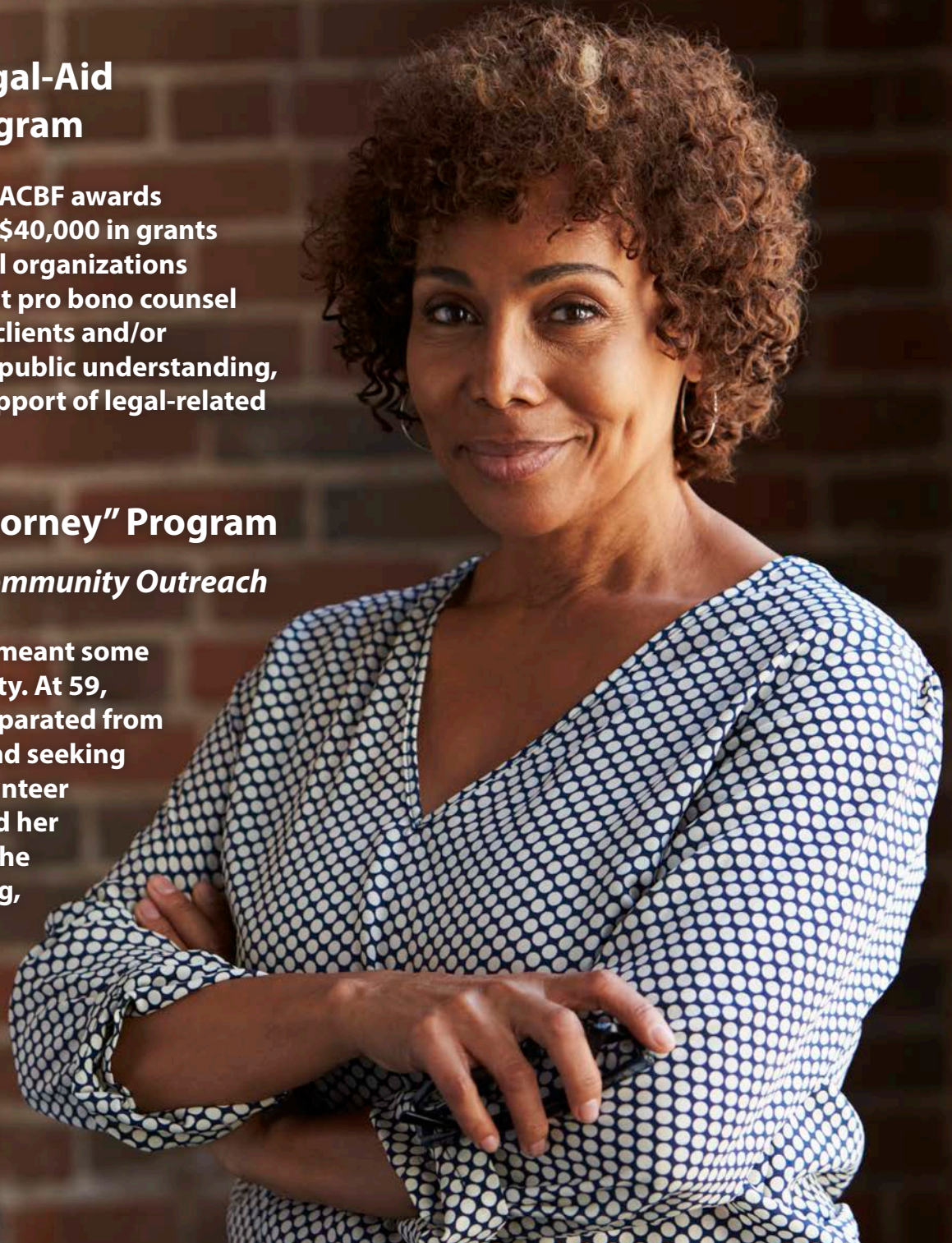
Fellows Legal-Aid Grants Program

North Hills Community Outreach

For Roberta, it meant some financial security. At 59, Roberta was separated from her husband and seeking alimony. A volunteer attorney helped her to prepare for the alimony hearing, and she was awarded alimony.



For Carol, it meant a safe and adequate place to live for her family. A young single mother, she was living in substandard housing and having significant problems with her landlord. She had a phone consult with a volunteer attorney who advised her on how to exit her lease so that she could move into a better house for her and her children.



For Katie, it meant the ability to assure for the care of a loved one. Katie was 72 when her adult son began having severe health problems that impacted his ability to function. A volunteer attorney assisted Katie and her son in establishing Katie as Power of Attorney for her son so she was able to handle his affairs while he was unable to do so.





At Tucker Arensberg, we have always taken our pro bono obligation seriously. Many of our attorneys, paralegals, and other team members contribute their time and expertise every year in a broad range of matters and projects. When we first learned about the Leadership Circle in 2012, though, we saw another opportunity to support the important work of the ACBF.

We learned that, even as the foundation's programs were growing, previously available funding sources were on the decline. Without enough resources, the ACBF's ability to deliver its pro bono and other programs would be reduced. We decided to participate in the Leadership Circle to help the ACBF not only continue, but to increase its important work throughout our community.

This initiative has been a great success and has helped the ACBF to add critical staff and expand its programs. Tucker Arensberg is proud to again be a part of the Leadership Circle.

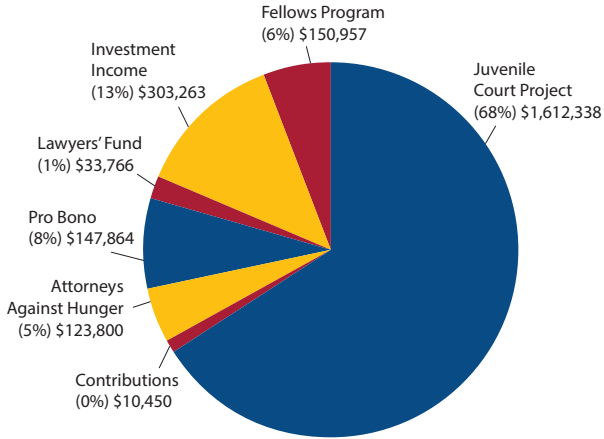
ACBA Professionalism Statement

Financials at a Glance

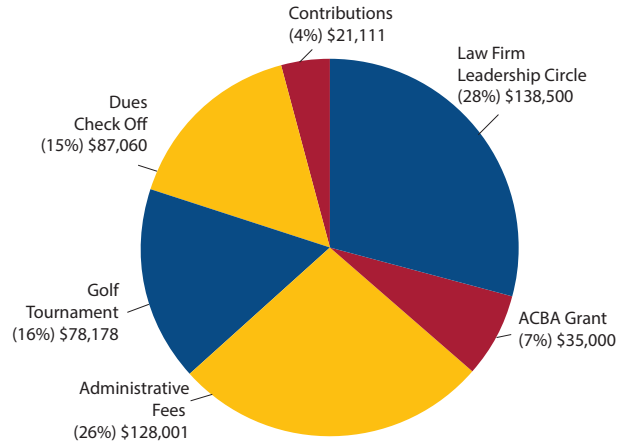

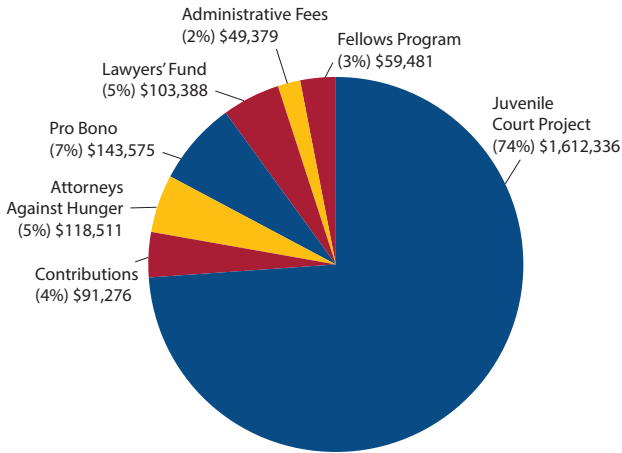


Total Revenue \$2,382,438

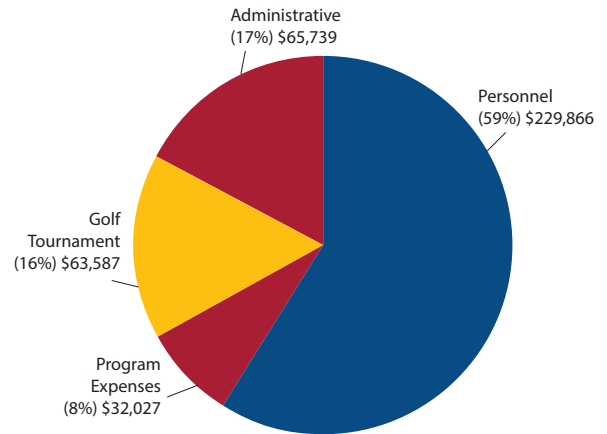
Unrestricted
