
For the staff attorneys of the Pro Bono Center, a large part of their day is spent directly assisting people who are facing a legal issue. At the same time, they are supporting volunteer attorneys who graciously lend their time and skills to individuals who cannot possibly afford an attorney. You will find them on hand assisting volunteers at community legal clinics, offering shadowing opportunities at PFA court, presenting at CLE programs, and supervising law students who are preparing pardon applications. They also manage volunteer resources such as free online legal research, CLE credits for pro bono hours, and certification for emeritus status. "We try to take on the same types of cases that we ask volunteers to do," says Barbara Griffin, Director of the Pro Bono Center. "That way we can share our actual experience with cases and let volunteers know what to expect." # Prepare a Pardon Application and Change a Life

What started as a limited, short-term project in 2020 has grown into an essential resource in Allegheny County for individuals seeking to get a fresh start in life by clearing criminal records through the pardons process. Since that time, the Pro Bono Center has filed 92 pardon applications and currently has over 40 open cases. Volunteer attorneys and law students have been an essential part of this work - and they make a difference. Our client "Robert" sought a pardon for an offense he committed over 40 years ago - the only case on his record. Robert had become a minister and had the support of community leaders, but his offense stood in the way of better employment opportunities. Volunteer attorney Kyle Black met with Robert to learn his story and prepare a statement to the Board of Pardons as to why he needed and deserved to have the slate wiped clean. After a hearing on his request, Robert received a unanimous 5-0 vote in favor of recommending a pardon, which Governor Wolf signed in February of this year.
