# Intersections of Law Impacting Individuals with Low Incomes CLE

Individuals with very low incomes who are struggling to meet their basic needs sometimes face several legal issues concurrently. This live webinar presented by the Access to Justice Committee will alert practitioners to intersections between criminal, family, housing, and immigration law and raise potential impacts that attorneys should explore further when representing clients.



## Connecting with Communities

Many people have never had the opportunity to sit down with an attorney to get help with a legal problem. The Pro Bono Center takes staff and volunteer attorneys outside of downtown and into neighborhoods to meet people where they are – at no cost to those with very low incomes. We offer regular legal clinics in Carnegie Borough and have held events in McKeesport and the Homewood, East Liberty, and Larimer neighborhoods of Pittsburgh.
