Fellows GIVE Pitch Event



The 2025 Fellows GIVE Pitch Event was held on October 21, 2025 at the August Wilson African American Cultural Center in downtown Pittsburgh. The ACBF's Grants Committee received a record

twenty applications this cycle and had to narrow down the applicants to a pool of ten for the pitch portion of the grant process. Ten organizations were selected and then Fellows GIVE member attendees at the event listened to pitches from the organizations and voted on which six they wanted to receive funding. The six organizations with the highest number of votes after the event then received a \$10,000 grant to support legal aid services in Allegheny County.

We look forward to continuing the tradition this year in October 2026.



AAH Outreach Event



On February 18, 2026, volunteers gathered at Allies for Health + Wellbeing to support an outreach event at their new location. Our team helped organize the first shipment to their food pantry and had the opportunity to tour the new facility, learning more about the expanded services they provide to our community. Meeting Emerging Needs

Starting last year, federal law began requiring a REAL ID to fly within the U.S. or enter some federal buildings. Some Pennsylvanians found themselves without accurate identification to acquire the new IDs. One such person—whose income was very low—needed an official name change to match the name she had used her entire life. The Pro Bono Center was ready to help.

The case was assigned to our law student intern, who prepared the petition and filed it with the court, where we obtained a fee waiver. After arranging for fingerprints, a judgment search, and publication of the hearing date, the student appeared in Motions Court and presented the petition. With a court order establishing her official name, our client was able to live her life fully. Our client wrote to us: “I really can’t express how grateful I am to both of you. To be able to use my name legally is a blessing. Now I can get my REAL ID and travel.”

Access to Justice Committee CLEs

Included in the mission of the ACBA/ACBF Access to Justice Committee is the charge to “investigate and study the problems affecting the delivery of legal services to indigent persons and recommend action to resolve those problems.” Chaired this year by Megan Lovette, the committee has organized two CLEs to educate the legal community on issues facing individuals with low incomes in need of help. The first will feature a screening of the short documentary “Pardon Me,” showcasing the stories of people who have suffered under the weight of their criminal record on May 5 at noon. The CLE will also train attorneys to handle criminal records clearing cases. Then, at the ACBA Bench-Bar Conference in June, the committee will present a CLE on “The Intersections of Law as Experienced by Unrepresented Litigants with Low Incomes,” an interactive program that will navigate a legal problem from the perspective of an unrepresented litigant while it alerts practitioners to intersections between criminal, family, housing, and immigration law.

Pro Bono Rocks



Pro Bono Rocks returned on October 11, 2025, to City Winery after a 12-year hiatus, bringing together approximately 140 attorneys, legal professionals, and community supporters for an unforgettable night of live music in celebration of 45 years of banding together for justice. Featuring performances by The Dead End Streets, The Centralians, and Repo Man, the evening raised over \$23,000 to support the Allegheny County Bar Foundation Pro Bono Center and its critical legal services for neighbors in need.
